

END-USER LICENCE AGREEMENT

This Licence Agreement is a legal agreement between the User, hereafter called "you", and MODARTT regarding the computer software named Organteq Alpha. Organteq Alpha in the following of the contract also includes any updates and supplements to the original Organteq Alpha provided to you by MODARTT. By installing, accessing or otherwise using Organteq Alpha, you agree to be bound by the terms of this Licence Agreement.

1 ORGANTEQ ALPHA LICENCE

Subject to the limitations described below, MODARTT, as licensor, hereby grants you, the licensee, a non-exclusive, perpetual licence to use Organteq Alpha.

1.1 GRANT OF LICENCE

This Licence Agreement grants you the following rights:

- (a) Software. You may install and use Organteq Alpha for an unlimited period on any Computer provided that this Computer belongs to you.
- (b) Reservation of Rights. All rights not expressly granted are reserved by MODARTT.

1.2 LIMITATIONS

- (a) Strict personal use. Your use of Organteq Alpha is limited to strict personal use. You may not rent or lease Organteq Alpha to another user.
- (b) Sound produced by Organteq Alpha can only be distributed within a musical context, and not in forms that allow the sounds to be used as sample based instruments or sample libraries.
- (c) Limitations on Reverse Engineering, Decompilation, Disassembly and Modification. You may not reverse engineer, decompile, disassemble or modify Organteq Alpha.
- (d) Limitations on usage. You may not merge Organteq Alpha into another software nor create derivative works based on Organteq Alpha.
- (e) Separation of Components. Organteq Alpha is licensed as a single product. Its component parts may not be separated.
- (f) Termination. Without prejudice to any other rights, MODARTT may terminate this Agreement if you fail to comply with the terms and conditions of this Agreement. In such event, you must destroy all copies of Organteq Alpha and all of its component parts.

1.3 COPYRIGHT

Organteq Alpha is protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. All title and intellectual property rights related to Organteq Alpha are owned by its authors. Unauthorized copying of Organteq Alpha, in whole or in part, is expressly forbidden. All title and intellectual property rights in and to the content which may be accessed through use of Organteq Alpha is the property of the respective content owner. This Agreement grants you no rights to use such content.

1.4 BACKUP COPY

After installation of Organteq Alpha, you may keep one copy of the file provided by MODARTT solely for backup or archival purposes, provided that its component parts are not separated. You may not distribute copies of Organteq Alpha.

1.5 OWNERSHIP

Organteq Alpha is licensed to you, not sold nor given. This Licence Agreement does not constitute a transfer or sale of ownership rights for Organteq Alpha. Except for the licence rights granted above, MODARTT retains all right title and interest for Organteq Alpha including all intellectual property rights therein.

2 WARRANTIES

Organteq Alpha is licensed without any warranty. It is provided on an “as is” basis.

3 LIMITATION OF LIABILITY

You agree that in no event will MODARTT be liable for any kind of damages, material, immaterial or corporal, that arise as a result of the malfunctioning or misuse of Organteq Alpha. You assume full responsibility for all possible consequences of your use of Organteq Alpha.

4 DISPUTE

This Licence Agreement is governed by the laws in force in France, and, in respect of any dispute which may arise hereunder, you consent to the jurisdiction of the courts sitting in Toulouse, France.
